The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes; hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be CNM ENTERPRISES, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address of the Company shall be 845 Bald Eagle Drive, Marco Island, Florida 34145. The street address of the initial principal office of the Company shall be 845 Bald Eagle Drive, Marco Island, Florida 34145.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

ARTICLE IV -- PURPOSE

The single purpose of the Company shall be to own and manage the real estate commonly known as 13245 Tamiami Trail East, Naples, Florida. In addition, the Company may invest the funds of the Company in real estate, mortgages, stocks, bonds, or any other type of investment, and own other real and personal property consistent with its purpose. In addition, the Company shall have the power to do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do any other act which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation.

ARTICLE V -- REGISTERED OFFICE AND AGENT

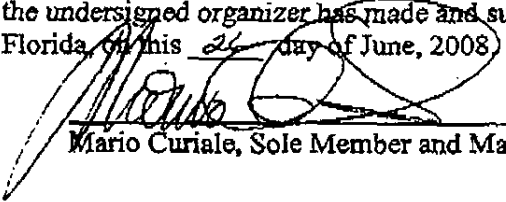
ARTICLE VI -- MANAGEMENT
