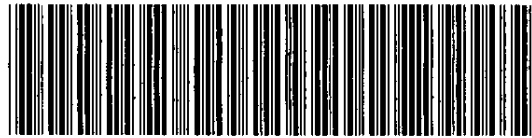



Nationwide Foam Adhesive, LLC (document number L08000063289) hereby amends its Articles of Organization and states as follows:


1. The name of the limited liability company is Nationwide Foam Adhesive, LLC.
