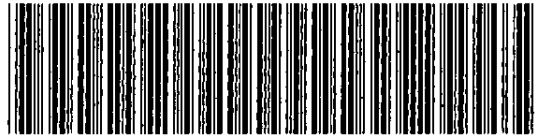


**ARTICLE IV – PURPOSE**

The Limited Liability Company's activities shall be limited to which are substantially related to the tax exempt purpose of its Member.


