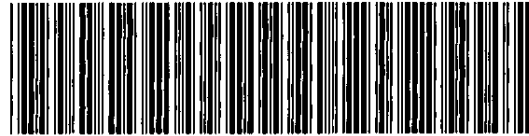

The Articles of Organization of this Company may only be amended by the majority vote of the members and in compliance with the other limitations in these Articles of Organization.

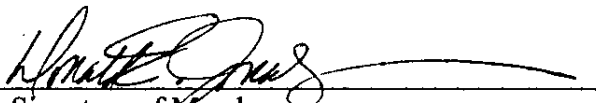
No members shall be obliged to contribute additional capital to the Company unless such obligation is approved and required by a majority vote of the members.
