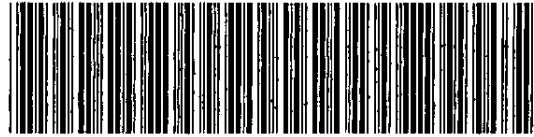



**ARTICLES OF ORGANIZATION OF
RIKE PROPERTIES #1, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "RIKE PROPERTIES #1, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 10900 NW 115th Avenue, Reddick, Florida 32686.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

**ARTICLE IV - DESIGNATION OF REGISTERED AGENT
