**ARTICLES OF ORGANIZATION OF  
RIKE PROPERTIES #2, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I - Name**

The name of the limited liability company (hereinafter referred to as the "Company") is "RIKE PROPERTIES #2, LLC."
