## ARTICLES OF ORGANIZATION OF SPRINGDALE ENTERPRISE, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be Springdale Enterprise, LLC (the "Company").
