THE UNDERSIGNED, under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, adopts, and files the following Articles of Organization:

**ARTICLE I — NAME**

The name of the limited liability company is BONITA PERIODONTICS & IMPLANTS, PLLC, (the "Company").

**ARTICLE II — ADDRESS**

The mailing address and street address of the principal office of the Company is 25099 PINEWATER COVE LANE, BONITA SPRINGS, FL 34134.

**ARTICLE III — REGISTERED AGENT & REGISTERED OFFICE**

The name and the Florida street address of the registered agent is AARON A. FARMER, P.L., 720 Fifth Avenue South, Suite 200, Naples, Florida 34102.

**ARTICLE IV — PURPOSE**

The general purposes for which this Company is organized shall be to render professional periodontal dentistry and dentistry to the general public, and to do all things in connection therewith that are customarily performed by a licensed dentist and/or periodontist under the laws of the State of Florida. In furtherance of its corporate purposes, the Company shall have all of the general and specific powers and rights granted to and conferred on a limited liability company by the Professional Service Corporation and Limited Liability Company Act.

**ARTICLE V — LIMITATION ON MEMBERSHIP**

No one other than an individual who is duly licensed or legally authorized to render licensed dentistry in the State of Florida or an organization described in Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act may become a member of the Company. No member of the Company shall enter into an agreement vesting another person with the authority to exercise the voting power of any membership interest in the Company. Any member who becomes legally disqualified to render shall sever all employment with and financial interest in the Company. No Member of the Company may sell or transfer his stock in the Company, except to another individual or an organization eligible to become a Member of the Company.

## ARTICLE VI – MANAGEMENT

The Company shall be managed by its members and is, therefore, a member-managed company. The name and the address of the managing member of the Company is JUAN M. TEODORO, 25099 PINEWATER COVE LANE, BONITA SPRINGS, FL 34134.
