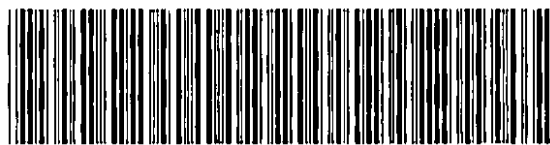


1. ARTICLE I – NAME is deleted in its entirety and replaced with the following:
