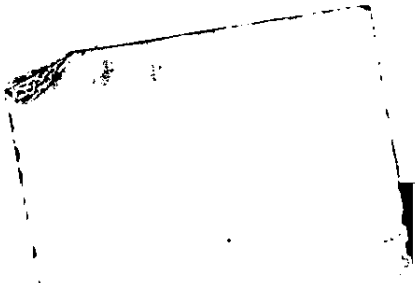

ARTICLES OF DISSOLUTION

- SECOND:** The date of the adoption of these Articles of Dissolution is 24 March 2009.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
