Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

FIRST: The name and address of this Company is **EL SHADDAI PROPERTY MAINTENANCE GROUP LLC**, 14035 SW 91st Terrace, Miami, Florida 33196.

SECOND: The date of the adoption of these Articles of Dissolution is 24 March 2009.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421.
