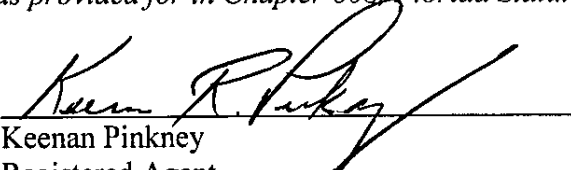
8.2 The Members shall enjoy voting power and authority in proportion to their Interests.
