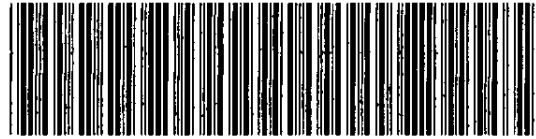

ARTICLES OF ORGANIZATION FOR  
PROFESSIONAL SERVICE LIMITED LIABILITY COMPANY
