AMENDED AND RESTATED ARTICLES OF ORGANIZATION

ED SPECIALISTS, PLLC A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

The Articles of Organization for ED SPECIALISTS, PLLC (the "Company") were filed on July 8, 2008. This Amended and Restated Articles of Organization for the Company is intended to supersede and replace the original Articles of Organization of the Company in its entirety. Upon the filing of this Amended and Restated Articles of Organization for the Company with the Secretary of the State of Plorida, the original Articles of Organization of the Company shall be of no further force and effect.

The undersigned, for the purpose of forming a professional limited liability company, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I. NAME. The name of the Professional Limited Liability Company is "EDSPECIALISTS, PLLC"

ARTICLE II. ADDRESS. The mailing address and principal street address of EDSPECIALISTS, PLLC is 14115 South Dixie Hwy, Suite L, Palmetto Bay, FL 33176.

ARTICLE III. PURPOSE. The purpose for which EDSPECIALISTS, PLLC is organized is:

- (a) To engage in psycho-educational evaluations, consultations, professional development and other services to the public that a school psychologist, licensed under the State of Florida, is allowed to render;
- (b) In general, to carry on any and all incidental business; to have and exercise all of the powers conferred by the laws of the State of Florida, and to do any and all things as set forth in these Articles to the same extent as a natural person might do;
- (c) To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to which this professional limited liability company is authorized to carry on, pursuant to the provisions of these Articles, and to hold, utilize, and in any manner dispose of the rights and property so acquired; and
- (d) To have, in furtherance of the company purposes, all of the powers conferred upon professional limited liability companies organized in the State of Florida,

subject to any limitations thereof contained in these Articles of Organization, in Chapter 621 of the Florida Statutes, or any laws of the State of Florida

ARTICLE V. MANAGEMENT. The Company shall be managed by a manager or managers in accordance with the operating agreement adopted by the members for the management of the business and affairs of the Company.
