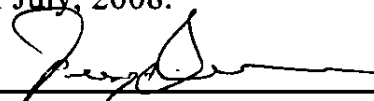
### ARTICLE VIII – Nonliability

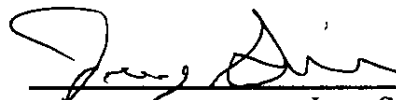
