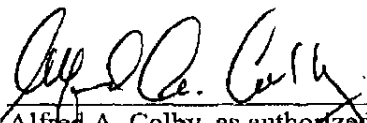
ARTICLE IV

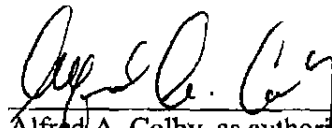

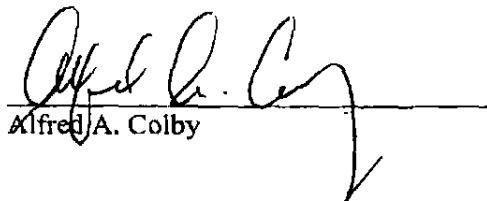
