ARTICLES OF ORGANIZATION

FOR

PREMIER MANAGEMENT SERVICES OF SOUTH FLORIDA, LLC

I. NAME

The name of the limited liability company (the "Company") is

PREMIER MANAGEMENT SERVICES OF SOUTH FLORIDA, LLC

II. DURATION

The period of duration of the Company is perpetual unless terminated pursuant to its Operating Agreement.

III. BUSINESS ADDRESS

The address of the place of business of the Company is 320 South Flamingo Road, # 354, Pembroke Pines, Florida 33027.

IV. REGISTERED AGENT

Except as may be otherwise provided in the Operating Agreement, an assignee of a member's interest in the Company may become a member of the Company, and acquire the rights and powers and be subject to the restrictions and liabilities of a member of the Company, upon the affirmative vote of all of the members of the Company (excluding the member seeking to transfer his interest in the Company) which vote is taken at a duly called meeting of the members or by written consent of the members of the Company (excluding the member seeking to transfer his interest in the Company) as set forth in the Operating Agreement, provided such assignment and admission of such assignee as a member complies with the terms and conditions of the Operating Agreement of the Company.

VII. CONTINUITY OF BUSINESS

The right, if given, of the remaining Members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company shall be as set forth in the Operating Agreement of the Company.

VIII. MANAGEMENT

The Company shall be managed by managers or managing members. The name and addresses of the initial managing member is set forth below. The initial managing member shall serve as managing member until the first annual meeting of Members or until its successor is elected and qualify.

ARTICLE X. DISSOLUTION OF COMPANY



Pursuant to Section 608.423(1), Florida Statutes, the managers of the Company may adopt, alter, amend or repeal any provision of the Operating Agreement upon the affirmative vote of all of those managers of the Company in attendance at a meeting of the managers duly called at which a quorum exists or by written consent of all of the managers of the Company; provided, however, any provision which has been previously adopted, altered or amended by the members and which states that it may only be amended, altered or repealed by the members, may not be altered, amended or repealed by the managers but shall only be amended, altered or repealed upon the affirmative vote of all of the members of the Company which vote is taken at a duly called meeting of the members or by written consent of the members of the Company.
