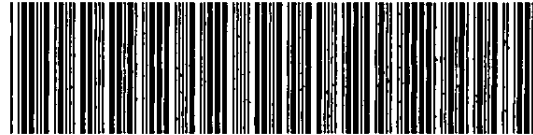



**ARTICLES OF ORGANIZATION  
OF  
GARAGE KINGS OF AMERICA, LLC**

The undersigned, acting as an authorized representative of the initial members of the captioned limited liability company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization.

**ARTICLE I - NAME**

The name of this limited liability company is GARAGE KINGS OF AMERICA, LLC (called the "Company") and the mailing address and street address of its principal office is 13285 N.W. 6<sup>th</sup> Place, Plantation, Florida 33324.

**ARTICLE II - EFFECTIVE DATE**

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State.

**ARTICLE III - PURPOSE OF ORGANIZATION**

The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under the laws of Florida.

**ARTICLE III - INITIAL REGISTERED AGENT  
AND REGISTERED OFFICE**

The name and the Florida street address of the Company's initial registered agent are: Stephen M. Feidelman, Esq., 2134 Hollywood Boulevard, Hollywood, FL 33020.

**ARTICLE IV - MANAGEMENT**

This Company will be managed by one or more members appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be member-managed. The member-managers may also be designated as the president, secretary, and treasurer of the Company, and may also be designated as vice presidents, assistant secretaries, and assistant treasurers, and shall have the authority normally associated with these positions under corporate law. The Company may also designate persons as directors under the Operating Agreement who shall act in a manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually, shall designate the member-managers and the positions that these member-managers will hold. The initial member-managers, who shall serve until the first annual meeting of the members or until their successors are elected and qualify, and their designations shall be as follows:    Name: Chet Mallard                      Position: President and Managing Member.

## ARTICLE V - OPERATING AGREEMENT

The power to adopt, alter, amend or repeal an Operating Agreement governing the operation of the Company shall be vested in its members.

## ARTICLE VI - INDEMNIFICATION


If the criteria set forth in §608.4363, *Florida Statutes*, or any successor statute, have been met, then the Company shall indemnify any Manager or member, or former Manager or member, his or her personal representatives, devisees or heirs, in the manner and to the extent contemplated by §608.4363, *Florida Statutes*.

## ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS

The remaining members may admit additional members only upon such terms and conditions of admission as shall be set forth in the limited liability company operating agreement for the company.

## ARTICLE VIII - MEMBERS RIGHTS TO CONTINUE BUSINESS

The remaining members of the Company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company upon such terms and conditions as shall be set forth in the limited liability company operating agreement for the Company.



## CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE


