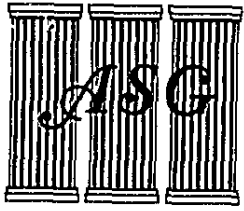



Management (Management by Members)**

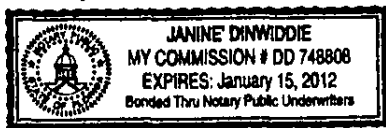


