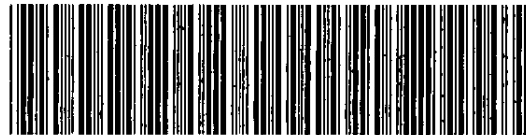

OF




