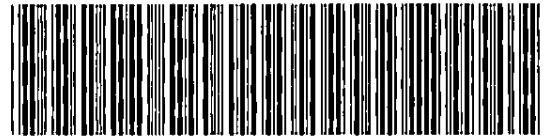

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
AMERICAN FLIGHT TRAINING LLC**

American Flight Training LLC (the "*Company*") was formed as a limited liability company under the Florida Limited Liability Company Act (the "*LLC Act*"), pursuant to the filing of Articles of Organization for American Flight Training LLC with the Florida Department of State (the "*Department of State*") on July 9, 2008. The undersigned, in order to amend and restate the Articles of Organization of the Company in their entirety, pursuant to Section 608.411(5) of the LLC Act, do hereby acknowledge and certify to the Department of State as follows:

ARTICLE I - NAME

The name of the Company is American Flight Training LLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 7501 S AIRPORT RD PEMBROKE PINES, FL 33023.

ARTICLE III - REGISTERED AGENT

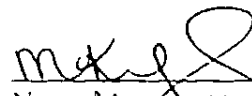
