1.2 SPECIFIC PURPOSE

1.3 ARTICLES OF ORGANIZATION OF TUTAISJURK, L.L.C.

The undersigned, desiring to form a limited liability company under and pursuant of Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

1.4 ARTICLE I NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Tutaisjurk, L.L.C." herein referred to as the "Company".

1.5 ARTICLE II BUSINESS ADDRESS

The Company's street address of its principal place of business in Florida is 1952 Waterford Ridge Road, Fort Walton Beach, FL, 32566, but it shall the power and authority to establish branch offices at such place or places as may be designated by the members.

Beginning on the date these Articles of Organization are filed with the Florida Department of State, the period of the Company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminated the continued membership of a member, unless the business of the Company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the foregoing events.

1.8 ARTICLE V PURPOSE

In addition, the Company shall have unlimited power to engage in and do any lawful act concerning any or all lawful business for which limited liability companies may be organized according to the laws of the State of Florida, excluding banking and insurance, including all powers and purpose now and hereafter permitted by law to a limited liability company.

1.9 ARTICLE VI MANAGEMENT

The business of the Company shall be managed by its members in proportion to their contributions to the capital of the Company as adjusted from time to time to properly reflect any additional contributions or withdrawals by the members.
