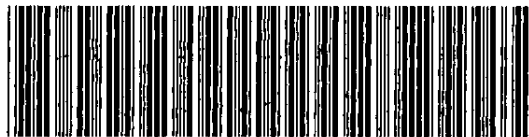

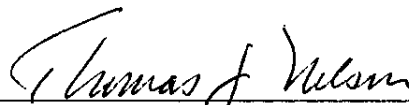

ARTICLE VI - Amendments:

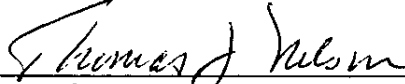
