**ARTICLES OF ORGANIZATION
OF
AGJ GULFSTREAM, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE 1
NAME**

The name of the limited liability company is AGJ Gulfstream , LLC (the "Company").
