**ARTICLES OF ORGANIZATION
OF
GULFSTREAM CAPITAL PARTNERS, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE 1
NAME**

The name of the limited liability company is Gulfstream Capital Partners, LLC (the "Company").

**ARTICLE 2
PERIOD OF DURATION**

The duration of the Company is perpetual, subject to termination in accordance with the Company's Operating Agreement or by the written agreement of the members.
