**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be Sunset Lakes Dental Group, LLC (the "**Company**").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company shall be 6345 NW 26th Terrace, Boca Raton, Florida 33496.

ARTICLE III – DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization or the members of the Company shall consent in writing to discontinue the Company.

ARTICLE IV – REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Stanford R. Solomon at The Solomon Law Group, P.A., 1881 West Kennedy Boulevard, Tampa, Florida 33606-1606.

ARTICLE V – CAPITAL CONTRIBUTIONS

The member(s) of the Company shall contribute to the capital of the Company the cash or property set forth in Exhibit "A".

ARTICLE VI – ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only on the unanimous written consent of all of the members.

ARTICLE VII – ADMISSIONS OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous prior written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate to any degree whatsoever in the management of the business and affairs of the Company or to become a member unless and until all of the other members of the company (other than the member proposing to dispose of his or her interest) approve of the proposed transfer by unanimous written consent.

ARTICLE VIII – TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy or dissolution of a manager, unless the business of the Company is continued by the unanimous written consent of all of the remaining members, provided there is at least one remaining member.

ARTICLE IX – MANAGEMENT

The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 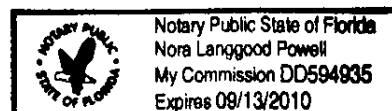
