1. Name. The name of this limited liability company is Frequency Holders, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

4. Place of Business. The mailing address and street address of the Company's principal office is 10050 Lake Cove Drive #302, Fort Myers, Florida 33908.



8. Certificated Interests. The members' interests in the Company may be evidenced by certificates.
