ARTICLES OF AMENDMENT
to
ARTICLES OF ORGANIZATION
of
ALLFR8 GLOBAL LOGISTICS & DISTRIBUTION, LLC

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is AllFr8 Global Logistics & Distribution, LLC (the "**LLC**").
2. The effective date of filing of the Articles of Organization (the "**Articles**") of the LLC was July 14, 2008.
3. The sole member of the LLC is Curtis H. Englert (the "**Member**").
4. The Member deems it to be in the best interest of the LLC to amend Article 1 to the Articles of the LLC.
5. That Article I of the Articles of the LLC is hereby amended in its entirety to read as follows:


ARTICLE I

NAME AND ADDRESS
