ARTICLES OF AMENDMENT
to
ARTICLES OF ORGANIZATION
of
ALLFR8 TRANSLOAD, LLC

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is AllFr8 Transload, LLC (the "**LLC**").
2. The effective date of filing of the Articles of Organization of the LLC was July 12, 2008, as amended by Articles of Amendment filed on February 9, 2010 (the "**Articles**").
3. The sole member of the LLC is Curtis H. Englert and Kelly Englert, Husband and Wife, as Tenants by the Entirety (the "**Member**").
4. The Member deems it to be in the best interest of the LLC to amend Article I to the Articles of the LLC.
5. That Article I of the Articles of the LLC is hereby amended in its entirety to read as follows:

ARTICLE I

NAME AND ADDRESS

The name of the limited liability company shall be AFI Transload, LLC (the "**Company**"). The mailing and street address of the principal address of the Company in Florida shall be 6885 Belfort Oaks Place, Suite 230, Jacksonville, Florida 32216.

6. The foregoing amendment shall become effective as of the date these Articles of Amendment are filed with the Secretary of State of Florida.
