AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR
YAMA350, LLC

The original articles of organization for Yama350, LLC were filed on July 15, 2008 with the Florida Department of State and assigned document number L08000068147. Now, by consent of all of the Members, Yama350, LLC hereby amends and restates its Articles of Organization as follows:

ARTICLE I

NAME AND ADDRESS

The name of this Limited Liability Company shall be Yama350, LLC (the "Company"). The mailing address and street address of the principal office of the Company is c/o 800 Laurel Oak Drive, Suite 300, Naples, FL 34108.

ARTICLE II

DURATION

The Company shall exist perpetually until dissolved pursuant to a written agreement of all members of the Company, or as provided by law, or as provided by the Company's Operating Agreement.

ARTICLE III

DESIGNATION OF REGISTERED AGENT

The name and address of the registered agent and office of the Company shall be Marguerite Quevedo, c/o 800 Laurel Oak Drive, Suite 300, Naples, FL 34108.

ARTICLE IV

THE MEMBERS

The members of the Company (hereafter the "Members") shall be:

ARTICLE V

MANAGEMENT OF COMPANY BUSINESS

The Company's day to day business will be managed by one of its members and is therefore a member-managed company. The Managing Member is Richard F. Corace.

ARTICLE VI

ADDITIONAL MEMBERS

The Members may admit additional members upon issuance of a Certificate of Membership signed by all the existing Members.

ARTICLE VII

LIMITATIONS ON MEMBERS

The Members shall not take any action on behalf of this Company that is prohibited by the Florida Limited Liability Company Act, or any action that requires consent of the other Members of the Company without first obtaining the prior written consent of all Members of the Company. Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no Member of the Company shall be an agent of the Company solely by virtue of being a member, and no Member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

ARTICLE VIII

RIGHT TO CONTINUE BUSINESS OF COMPANY

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of any Member of the Company, or upon the occurrence of any other event that terminates the continued membership of a Member in the Company, the remaining Member or Members shall

ARTICLE IX

AMENDMENTS

These Articles may be amended from time to time by the written consent of all Members of the Company.

These Amended and Restated Articles of Organization are duly executed and are being filed in accordance with the provisions of Section 608.411, Florida Statutes.


