ARTICLES OF ORGANIZATION OF NU BEGINNINGS MANAGEMENT, LLC

ARTICLE I Name

The name of this limited liability company is NU BEGINNINGS MANAGEMENT, LLC.

ARTICLE II Existence

This limited liability company shall have perpetual existence.

ARTICLE III Purpose
