**ARTICLES OF ORGANIZATION  
OF  
NU BEGINNINGS MANAGEMENT, LLC**

**ARTICLE I  
Name**

The name of this limited liability company is NU BEGINNINGS MANAGEMENT, LLC.

**ARTICLE II  
Existence**

This limited liability company shall have perpetual existence.

**ARTICLE III  
Purpose**

This limited liability company is created for any lawful purpose (except that special statutes for the regulation and control of specific types of businesses shall control when in conflict herewith) and for the benefit of its members and such business as may be agreed on by its members.

**ARTICLE IV  
Registered Agent and Address**

The mailing and street address of the principal office of the limited liability company shall be 37 N. 3. The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member of this limited liability company, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall not result in the dissolution of this limited

liability company. Rather, the remaining members of the limited liability company shall have the right to continue the business of the limited liability company notwithstanding the foregoing events.

**ARTICLE VI**  
**Management of Company**

The management of the limited liability company shall be vested in a manager (the "Manager") who shall be elected by the members in a manner prescribed by and provided for in the regulations of the limited liability company. The Manager also shall hold the offices and shall have the responsibilities accorded to it by the members and as set out in the regulations of the limited liability company. **Effective Date of Company**

The Effective Date of the existence of the Company shall commence on the date of execution and acknowledgment of these Articles of Organization, provided that these Articles of Organization are filed with the State of Florida Department of State within five (5) business days of such date. Otherwise, corporate existence shall commence on the date of filing of these Articles of Organization.
