ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SPARK & PRODUCTS LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 300 East Oakland Park Boulevard, #124, Wilton Manors, Florida 33334 and the mailing address shall be the same.
