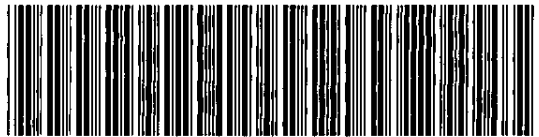

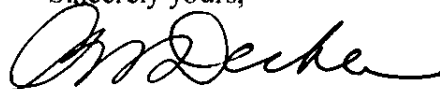

AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

PAXIMUS, LLC

Pursuant to Chapter 608 of the Florida Statutes, the undersigned member of PAXIMUS, LLC, hereby amends and restates the Articles of Organization originally filed with the Secretary of State on July 18, 2008, by adopting for the limited liability company the following Amended and Restated Articles of Organization which have been duly executed and filed under Section 608.411 of the Florida Statutes.

ARTICLE I - Name

The name of the limited liability company is: PAXIMUS, LLC (hereinafter the "Company").

ARTICLE II - Address

The mailing address of the Company is 9059 129th Drive, Live Oak, Florida 32060 and the street address of the principal office of the Company is 9059 129th Drive, Live Oak, Florida 32060.

ARTICLE III - Duration and Purpose

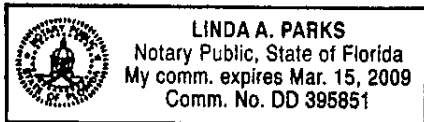
