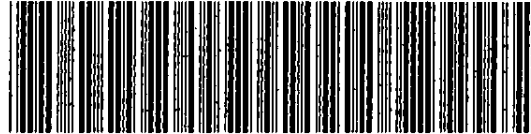

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be as set forth in the Regulations of the LLC.


**ARTICLE VI – Members' Rights to Continue Business**



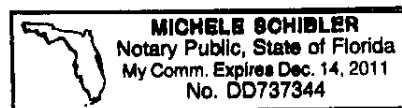
