A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned, Member and/or authorized representative thereof, being competent to contract, subscribes to these Articles of Organization to form a Florida Professional Limited Liability Company pursuant to Chapter 621 and Chapter 608 of the Florida Statutes, and hereby adopts the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company shall be:
