ARTICLES OF ORGANIZATION  
OF  
MYCARDIOLAB, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I  
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is MYCARDIOLAB, LLC.

ARTICLE II  
ADDRESS

The Company's street address of its principal place of business in Florida is 1725 East LaRue Street, Pensacola, Florida 32501 and its mailing address is 1725 East LaRue Street, Pensacola, Florida 32501, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III  
MANAGEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the members. An Operating Agreement adopted by the Members may be repealed or altered, or new operating agreement may be adopted by the members.
