ARTICLES OF ORGANIZATION OF INTERTADE, LLC

The undersigned certifies the purpose of organizing a limited liability company under the laws of the State of Florida, Florida Statute 608-Florida Limited Liability Company Act, providing for the formation, rights, privileges, and immunities of limited liability companies for profit we further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

Article I NAME AND PRINCIPAL PLACE OF BUSINESS

- 5. 6. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same thall not be inconsistent with the laws of the State of Florida.
