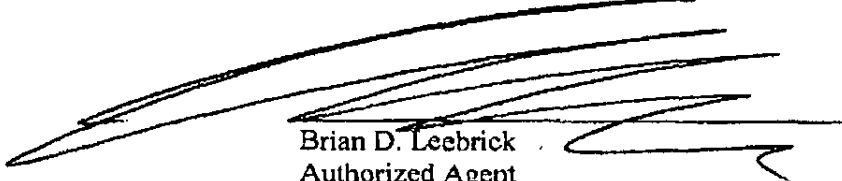
ARTICLE VI - MANAGEMENT

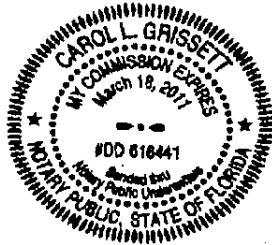

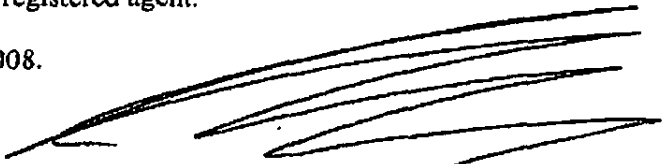

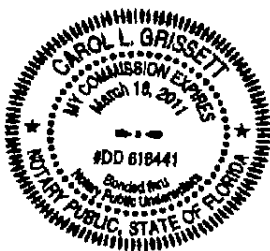
