1. The name of this Company is currently THE MORGAN EXECUTIVE DEVELOPMENT INSTITUTE, LLC.

2. The Certificate of Conversion and Articles of Organization for this Limited Liability Company were filed on July 22, 2008 with an organizational date deemed effective February 25, 2002 and assigned Florida Document Number L08000070703.
