ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is LAKEVIEW ATL, LLC, and its principal office and mailing address is 2504 W. Gardner Court, Tampa, Florida 33611.

ARTICLE 2: DURATION

The duration of the Company is perpetual.

ARTICLE 3: PURPOSE

ARTICLE 7: ADMISSION OF ADDITIONAL MEMBERS

However, if all of the remaining members of this Company do not approve of such proposed transfer or assignment by unanimous written consent, the transferee of the interest of such member shall have no right to participate in the management of the business and affairs of this Company or to become a member.
