
Re: GEBO, LLC (W08000034621) (the "Company")

Dear Brenda:

This letter serves as the Company's request to have the Articles of Organization accepted with the name "GEBO, LLC". Although, there exists a Florida LLC by the name of "GEBO COMPANY, LLC", we believe the names are not similar in this case because "Company" is used as part of the proper name and not used as a suffix. GEBO COMPANY was established three years ago and, if it had desired to act under the name "GEBO" alone or to use "Company" as a suffix, it was clearly free to do so. However, it specifically chose the name "GEBO COMPANY, LLC", choosing to use LLC as its suffix. There are no other companies in Florida with the name solely as "GEBO", but GEBO is used in several other company names. Accordingly, we are requesting that the state allow filing of my client Articles of Organization under the name "GEBO, LLC".
