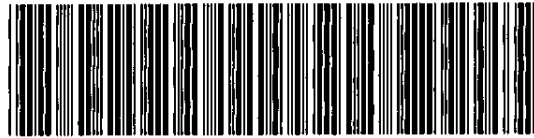

**ARTICLES OF ORGANIZATION  
OF  
YMK AUTO MOTORS, LLC  
(A Limited Liability Company)**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization:

**ARTICLE I**

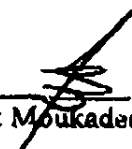
## ARTICLE VII
