**ARTICLES OF ORGANIZATION

The undersigned, WHOLESAL ELEC TRIC SUPPLY COMPANY, INC., a Texas corporation having legal authority to contract, hereby presents these Articles of Organization of GO & BM INVESTMENTS, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME
