ARTICLES OF ORGANIZATION OF VPD, LLC

The undersigned, for the purpose of forming a limited liability company under Estimated Liability Company Act, F.S. Chapter 608. hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be VPD, LLC ("company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified.
