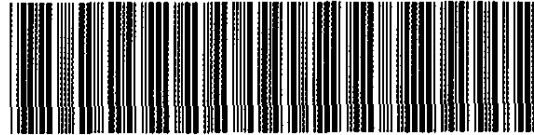

ARTICLES OF ORGANIZATION OF

THIS IS TO CERTIFY THAT:

FIRST: These Articles amend the Articles Of Organization of The Glen At Cagan Crossings Unit One, L.L.C., a Florida limited liability company.


SECOND: The Articles of Organization were filed with the Florida Department Of State on July 25, 2008.
