

ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF THE GLEN AT CAGAN CROSSINGS UNIT TWO, L.L.C.

THIS IS TO CERTIFY THAT:

FIRST: These Articles amend the Articles Of Organization of The Glen At Cagan Crossings Unit Two, L.L.C., a Florida limited liability company.

SECOND: The Articles of Organization were filed with the Florida Department Of State on July 25, 2008.

THIRD: Article 13 of the Articles Of Organization is hereby amended by deleting the existing Article 13 and replacing it with the following new Article 13:
