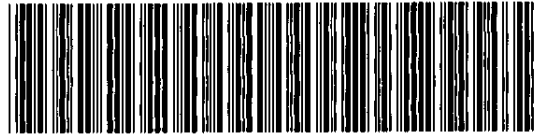

The Company shall be member-managed. The name and address of the Managing Member is as follows:




