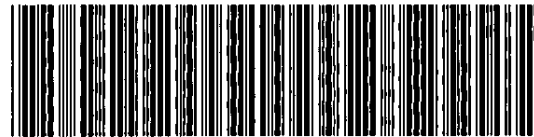

The Company is to be member managed and the name and address of the initial managing member is:

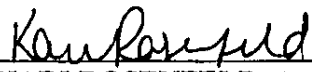

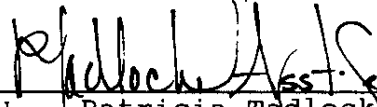
