**FOURTH:** The Limited Liability Company's dissolution pursuant to Section 608.441, Florida Statutes has occurred as a result of a written consent of the Members.


**FIFTH:** Adequate provision has been made for the debts, obligations and liabilities pursuant to Section 608.4421.

**SIXTH:** All remaining property and assets have been distributed among its Members in accordance with their respective rights and interests.


**SEVENTH:** There are no suits pending against the Limited Liability Company in any court.
